



Individual instruction is offered for harp, koto, piano, music theory/composition and all brass, woodwind and string instruments. Group classes are offered for Choirs, Music Together, Jazz Combos, Orchestra, Saxophone Ensembles and Suzuki Violin. Royal Conservatory Certification is also available. In 2019-2020 Music Center saw record enrollment with over 600 participants each week.

Outreach: Music Center provides Outreach instruction to over 80 students at Broadview Thomson K-8 and Lake Forest Park Elementary.
