Music Instruction: MCNW provides individual and group instruction to students of all ages and abilities. Individual instruction is offered for harp, koto, piano, music theory, ukulele and all brass, woodwind and string instruments. Group classes are offered for Choirs, Music Together, Jazz Combos, Orchestra, Ensembles and Suzuki Strings. Music Center saw record enrollment of over 600 students during the 2021-22 academic year.

Music Therapy: Music Therapy specializes in working with people of all ages, including neurodiverse individuals; those who have received a diagnosis of Autism, ADHD or Down Syndrome; and older adults experiencing dementia, Alzheimer's Disease, Parkinson's Disease, and other neurodegenerative diseases. Areas of focus may include language and self-expression, motor coordination, academic skills, self-advocacy and other goals, all while recognizing and building on each client's unique strengths and abilities.
